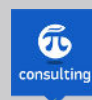

LOST2 Partners' Meetings and their relevance for the work carried out!

Since the beginning of 2024, LOST2 partners had the opportunity to meet twice in very relevant Transnational Partners' Meetings (TPMs) that allowed them to make an overview of the results achieved and set the course for the results to be achieved in the following period of the project's implementation.

Meeting in Oslo (Norway) | May 2024

Hosted by EUROMASC AS, this hybrid TPM had the participation from all partners to discuss the conclusion of the development process of LOST2 Qualification, which allows partners to go to the next phase – translate all contents and materials into the languages of the partnership (EL, EN, IT, NO and PT), and transfer those contents and materials to the future LOST2 Learning Platform.

Meeting in Athens (Greece) | October 2024

All LOST2 TPMs are special, but this hybrid meeting hosted by The Smile of the Child was even more special as it allowed all partners attending in person to better understand the work done by its Panhellenic Operational Centre in the field of missing children.

During this meeting, all partners involved in the pilots of the LOST2 qualification modules presented the main results of those pilots, which ultimately had impact on the tested contents and materials that now have to be revised and adjusted, accordingly.

Moreover, another crucial outcome of LOST2 was addressed – the project's Online Training Platform, where all of the qualification modules (contents and materials) will be publicly available at the end of the project implementation period to benefit the professionals across Europe involved in the search for missing persons.

LOST2 Qualification: Pilot sessions and results achieved

LOST2 Qualification "Experts in the Research of Missing People & Minors" is comprised of 13 modules which contents and materials are aimed at Vocational Education and Training (VET) Trainers and Technical Operators part of the project's partner organisations, and at:

- Members of the Police Force,
- Fire Fighters,
- Elements of the Civil Service/Civil Protection,
- Private Investigators and Lawyers,
- Local, National and European Authorities,
- Members who are volunteers at organisations that support families and help law enforcement services and public institutions working in the field of Missing Persons and Children.

The Structure of the Qualification

LOST2 Qualification "Experts in the Research of Missing People & Minors" has a total of 6 Courses, inside of which the above-mentioned professionals can find 13 different modules, developed based on the extensive experience and know-how of the project's partners, and with the contributions from external experts working in the field.

Those courses are:

Course 0 (introductory): Preventing and mitigating abduction

Course 1: Assistance and Prevention

Course 2: Family Support

Course 3: Research and Implementation

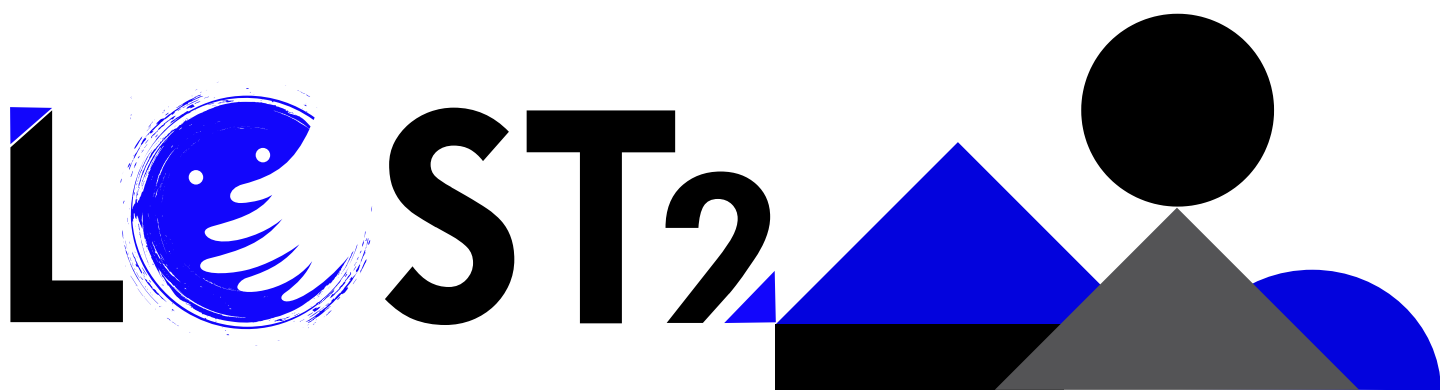
Course 4: Data collection and analysis

Course 5: Finalisation of investigation

Course 6: Identification of an unnamed body

Apart from the theoretical contents developed, the Qualification also contains exercises and other supporting materials (e.g., videos, literature references) that allow students to explore each topic more deeply.

All of these contents and materials will soon be available online at LOST2 Training Platform, translated into the languages of the partnership!



The Pilots

May 2024 marked the starting point for all partners to pilot LOST2 Qualification modules, with the active participation of experts and professionals working in the field of Missing Persons and Children.

Here are the testimonies of some of the LOST2 partners involved in these pilot activities:

Asociación SOS Desaparecidos (ES)

Held in May 25th, 2024 (the International Missing Children's Day), in Murcia, this session had 15 participants who explored Course 2 of LOST2 Qualification, more specifically the psychological support to families in the first phase of disappearance, and analysis of the disappearance and of the environment context.

Because the results of pilots carried out provide a source of information to all LOST2 partners involved in the development of the training contents, it was important to understand that, for all participants of this session, the most essential aspects that provide a comprehensive understanding of what effective assistance to families is are covered by this course.

EUROMASC (NO)

This LOST2 partner focused its pilot session on Course 0. Because this is a more introductory Course, the pilots were carried out online with a total of 14 participants, between June and July 2024.

At the end of this process, of the participants stated "I found the course to be exceptionally well-structured and concise. The content was clearly presented, and the learning objectives were thoroughly communicated. Overall, it provided me with a solid understanding of both the theoretical knowledge and practical applications discussed."

The Smile of the Child (EL)

This hybrid pilot session was held in June 2024, and focused on Course 3.

With a total of 19 participants (11 in person and 8 online), this session carried out by The Smile of the Child allowed to understand participants' perspectives about LOST2 Qualification in general, and this Course in particular. For them, pilots such as this allow participating professionals to be involved in cooperative activities that "lead to conclusions and recommendations for improvement of mechanisms for a more effective coordination and management in investigation, search and detection of missing minors and adults and should take place more frequently".

This was very important feedback to LOST2 as it means that this particular project activity is well regarded among the professionals targeted by the project's results and outcomes!

Looking Forward

After collecting these and other participants' inputs from the pilots carried out in Italy and in Portugal too, LOST2 partners will now analyse those inputs and make the necessary changes/adaptations to the tested contents and materials, to make sure that the Qualification "Experts in the Research of Missing People & Minors" complies with its purpose.

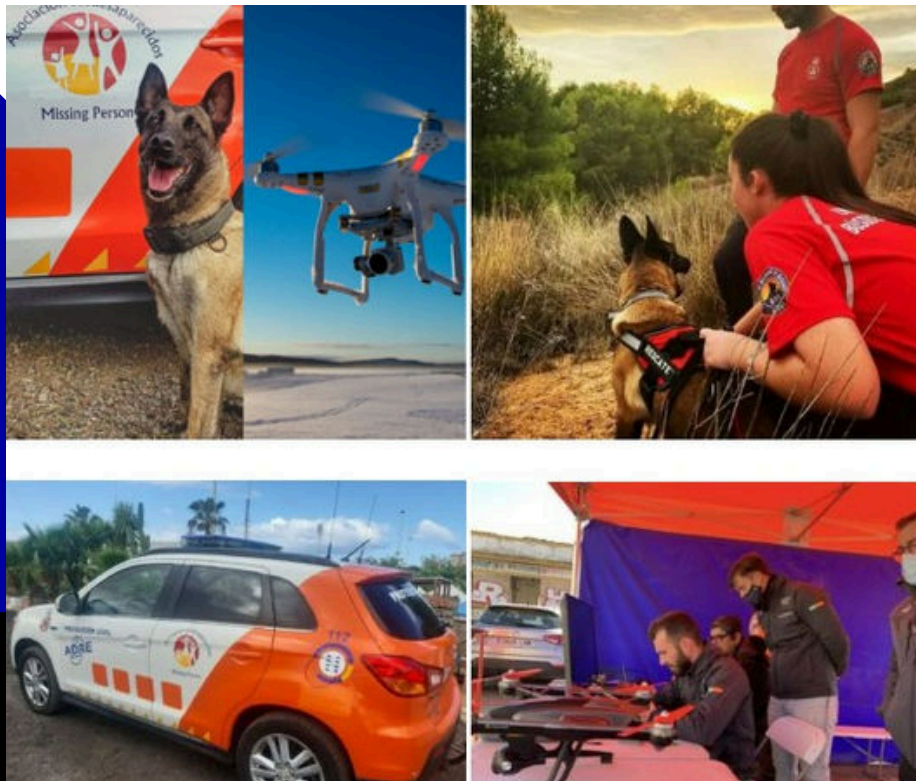
RIAD and its connection to LOST2

Asociación SOS Desaparecidos

In March 16th, Asociación SOS Desaparecidos launched its Immediate Action Network for Missing Persons (RIAD), which gathers Search Units of missing persons that will work across Spain whenever activated by law enforcement agencies.

This important milestone achieved by the Spanish LOST2 partner will increase the response capacity to missing persons and children situations, through the use of drone units and involvement of:

- Search dogs on the ground, which will move in the first moments;
- Civil protection units, with their teams and always activated by their command units;
- Volunteers from different entities, groups, platforms and organisations.



Moreover, the RIAD Teams include Psychologists, who will act at the request of the families or of the unit in charge of the disappearance and search, and Criminologists and Detectives, who will work at the request of the security forces or of the family of the missing person, once they have the authorisation of the investigation unit or of the court.

RIAD will be connected to LOST2 by using the project's Qualification to provide training to its volunteers!

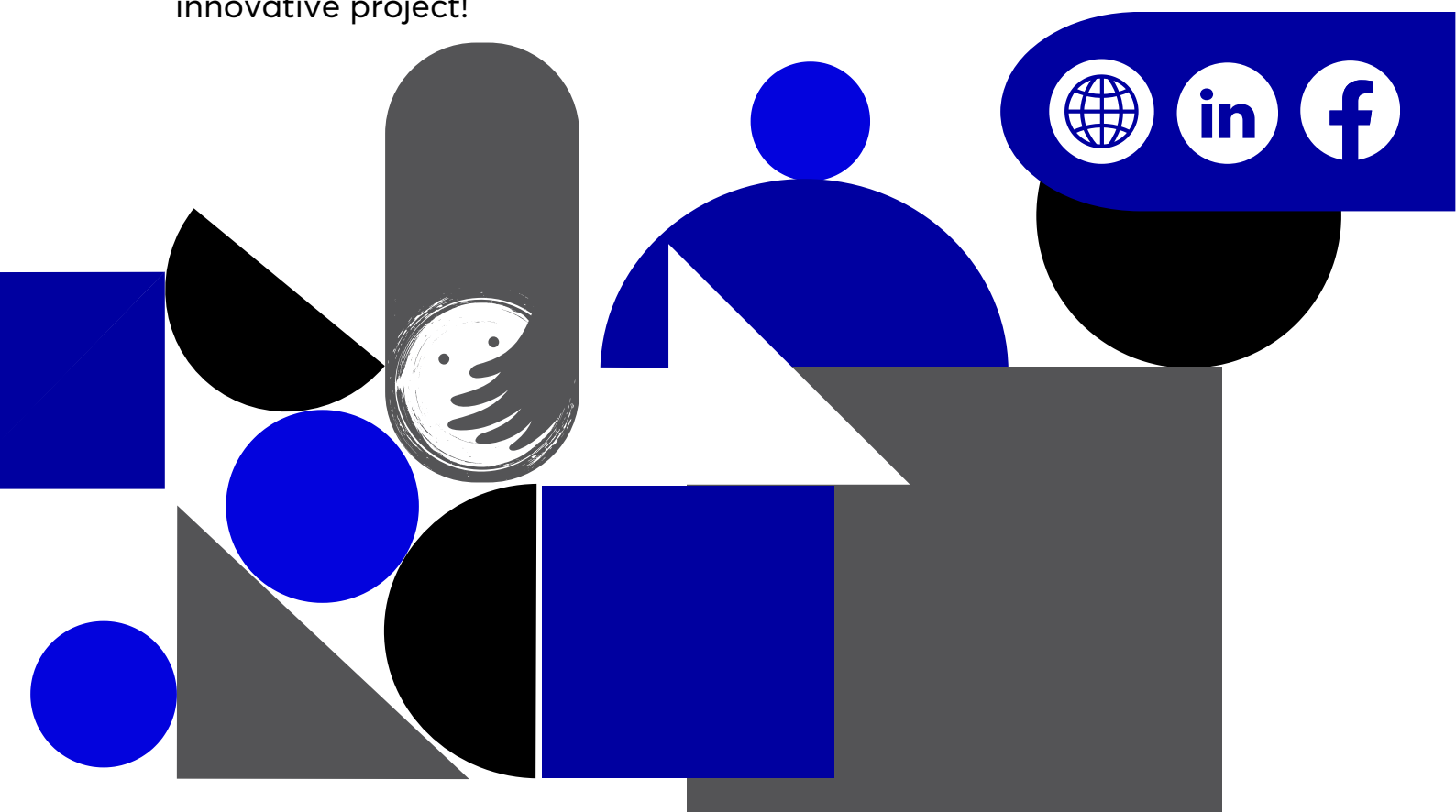
Next on LOST2

2025 represents the conclusion of the project, meaning that all results and outcomes of LOST2 will be ready and available to be used by all of the professionals working in the Missing Persons and Children phenomena!

Until then, here are some of the activities to be carried out by the end of May 2025:

- Finalisation of all adjustments to LOST Qualification materials (including the update of the Dictionary of Competences, which allows for alignment of the Qualification with ESCO and, ultimately, supports its formal recognition by Education and Training authorities);
- Translation of all those materials so they can be easily used in the countries of LOST2 partnership;
- Finalisation of LOST2 online Training Platform;
- Final TPM and International Conference of LOST2, to be held in Brussels (BE) in May 2025.
