July 2023

Joint Staff Training in Madrid, ES (4th - 6th July 2023)



The Joint Staff Training (JST) activity took place over three days, focusing on defining the objectives, methodologies, and tools for the training of professionals in the field of "Expert in the Research of Missing People and Children."
The training, which gathered LOST2 partners involved in the design of the project's qualification, aimed to align competencies with European standards and develop a comprehensive training program.

1st Day (4th July): Introduction to the Training Laboratory

- Objectives were to make an overview of the JST objectives, continuation of current tasks, and proposal of the LOST2 training platform engineering.
- **Activities implemented:**
 - Presentation by OMNIS and ARLAB on planned activities related to pilot training, documentation for qualification recognition, and alignment with European Skills, Competencies, and National Standards.
 - Focus on the Dictionary of Competencies for the professional profile of "Expert in the Research of Missing People and Children."

2nd Day (5th July): Proposal about the Standard of the Professional by EUROMASC

- Objectives were to address the interconnection between training and the profession, with a focus on European Standards, Units, and Learning Outcomes (LOs).
- **Activities implemented:**
 - Exploration of the relationship between competencies, Units, and LOs.
 - Methodology presentation by EUROMASC on creating Units and defining the European Qualifications Framework (EQF) level.
 - Discussion on the ESCO classification system for skills, competences, qualifications, and occupations relevant to the EU labour market.
 - Proposal of an assessment methodology for Learning Outcomes.

3rd Day (6th July): Proposal of the LOST2 Training Platform Engineering by p-consulting.gr

- Objectives were to validate the structure of the LOST2 Platform and discuss its connection with EU tools.
- **Activities implemented:**
 - Presentation by p-consulting.gr of the LOST2 website, including Units, Modules, and Training Contents
 - Discussion on the platform's connection to EU tools, description of the profession, organization of tutorials, and user guidance.
 - Proposal and sharing of a list of services by ARLAB, including user reception area, community interaction, and opinions and suggestions board.
 - Detailed features of the modules, navigation, and verification tests outlined for the Training Platform.

LOST2 partners gathered in Lisbon for the second Partners' Meeting, an opportunity to present the first result of the project, to discuss the project's progress and to set the next steps to take towards the achievement of LOST2 purposes.

Joint Staff Training activity in Perugia, 4th – 6th December 2023



Successful Joint Staff Training Unveils Progress for LOST2 Project in Perugia

In a significant stride forward, the LOST2 project partners convened in Perugia, Italy, for the second Joint Staff Training activity. The week-long event proved to be immensely successful, focusing on the pivotal theme of "Definition of competences at the European level for the recognition of the Qualification."

The intensive three-day training provided a platform for project partners to immerse themselves in the ongoing development of the LOST2 qualification, titled "Expert in the Research of Missing People and Children." A central point of discussion revolved around the necessary procedures for securing formal recognition of this qualification within the educational systems across the European Union.

Collaboration took centre stage as partners engaged closely with experts from associations specializing in the disappearance of minors. Additionally, valuable insights were gleaned from training professionals who actively contributed to shaping the design of the LOST2 qualification. This collaborative effort is set to bolster the qualification's comprehensive approach and relevance.

Looking ahead, the LOST2 Project is gearing up for a pilot training action. This forthcoming initiative aims to test the qualification among diverse stakeholders, including law enforcement agencies, lawyers, private individuals, and voluntary associations committed to the search for missing persons. The inclusive nature of this pilot underscores the project's dedication to ensuring the qualification meets the needs of professionals and stakeholders across the sector. The success of the recent training activity in Perugia sets a promising tone for the project's future endeavours.

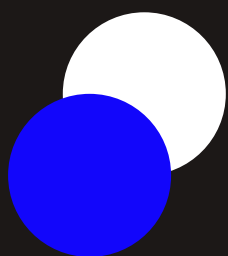
